DIFFRACTION raced along the rail, disputed the pace and gamely prevailed in an extended drive. CAMPFIRE BURNING stalked the pace, advanced three wide on the far turn, dueled through the lane and hung. CALVIN K , unhurried early, raced in the two path entering the stretch, remained on his left lead and rallied mildly under right hand whipping. ADOPTED ARRIVAL stumbled in close quarters soon after the break, swung wide in upper stretch and passed tired ones. SKIP THE CROWD raced along the rail and was not a factor. JOEL'S TOUCH bobbled at the break, raced three wide on the first turn, four wide the far turn and weakened. HOLA C BRIGHT disputed the pace two wide and gave way. There was a stewards' inquiry concerning the start and no action was taken.
