Footnotes

NICELITTLEPACKAGE , forwardly placed down the backstretch while three to four wide, angled to the inside mid way on the final turn, got through along the rail in upper stretch, opened up a furlong out and proved best under a drive. UNREPENTANT a bit unruly pre race, was taken to rate early while off the rail, raced between rivals leaving the three furlong marker, swung out seven wide in upper stretch and closed willingly to earn the place. COUNTY RECOUNT , taken to rate while saving ground, moved up some entering the lane, got room leaving the eighth pole, finished willingly but was edged for the place. CASEY JEAN settled well off the rail, advanced four wide leaving the far turn, lodged a mild bid mid way on the final turn, remained a presence to mid stretch then faded. PERFECT BUSINESS cleared early, set the pace towards the inside, took pressure leaving the three eighths pole, drifted out entering the lane and gave way. ANGELS AND SAINTS saved ground, raced forwardly into the far turn then gave way. BRILLIANT JEWEL , unhurried early while off the rail, made a mild four wide run nearing the quarter pole then weakened. LADY CASSANDRA rushed to contention, prompted the pace three wide, lodged a bid leaving the far turn, pressed the pace into the lane then surrendered.
