LEGAL CONTROL set the pace towards the inside, was collared leaving the far turn, dueled from the three furlong marker to mid stretch then edged clear under a drive. HE DEVIL, taken to rate four wide, moved up four wide under rating nearing the half mile marker, lodged a three wide bid around the far turn, dueled outside of the winner to mid stretch then gave way grudgingly. ART MAJOR, forwardly placed while off the rail, chased the leaders around the second turn then came up empty. CASANOVA EXPRESS saved ground chasing the pace, raced close up for five furlongs and gave way. SPECIAL CHARADE failed to threaten and tired. SHARE THE LOVE pressed the pace between rivals past the half mile marker and faltered. MY MAN ELLIOTT saved ground and broke down leaving the sixteenth marker
