BELLA SORELLA broke alertly, set the pace while off the rail to the stretch, edged away to mid stretch then was kept to task to hold. LIVE THE FORTH was outprinted to the turn, saved ground to the stretch then shifted off the rail and finished willingly late. JUST LET ME FINISH tracked the pace to the turn, offered a bid three wide to the stretch but was outkicked by the winner to mid stretch and failed to rally while just saving the show. OCEANA also tracked the pace to the turn, raced three wide to the stretch but could not muster the needed response. ICETOANESKIMO had no speed and saved ground to no avail. STRAWBERRY ROUTE pressed the pace early, saved ground to the stretch then tired in the final furlong. SWIM SUIT MODEL was stalking the winner early, got outrun while two then three wide to the stretch and failed to rally in the drive. SUMMER ROUGE was outprinted to the turn then got fanned five while while circling rivals to the stretch and also did not rally. HOT BY ASSOCIATION was inside of SUMMER ROUGE to the turn, raced four wide to the stretch but did not threaten. BOONDY'SBOOMBOOM hopped at the start and trailed throughout.
