**Footnotes**

NO GOING BACK pressed the pace three wide from the outset, challenged for command at the quarter pole then dueled with THRICE THE VICE to the wire from the outside and took a narrow decision. THRICE THE VICE dueled from between horses to the stretch, battled the winner in a hard fought duel but drop a narrow decision. WORLD OF COLOR pressed the pace from the rail to the quarter pole and slackened. PIMIENTO NEGRO settled early, raced in the four path on the turn but had no rally. KALIHI EXPRESS raced close up early but faded while two wide on the turn. LAST BLEND lacked good early speed, advanced two wide on the turn but could not sustain the rally. FUNNYDREAM raced three wide and was never a factor. SOUND OF MONEY broke slow and was always outrun. BLUE MOON SLEW lacked good early speed, saved ground and failed to respond. OH ME OH MY was never a factor while racing well off the rail.
