Footnotes

PRIMARY NOTICE prompted the pace to the turn, raced two wide to the stretch, responded to steady pressure and wore down VENOM G in the late stages. VENOM G stalked the leader to the turn then went after that one three wide, pushed to the front into the stretch, raced clear to mid stretch then could not stall the winner's run. SHAKIN' JAKE was quickest early, set the pace to mid turn, was overtaken by the runnerup into the stretch but kept to task to stay close to the wire. BEV'S EX never far back to the turn, raced three deep to the stretch and found his best stride in the late stages. SEAFIRE was outsprinted, raced two wide to the stretch then could not make an impact in the drive. NYMEGEN PITA had no speed, was three wide to the stretch and lacked a closing response. CHRISTIE'S GLORY chased the pace to the turn then was fanned four wide to the stretch and weakened through the drive. SCOTT'S SPIRIT broke flat footed and lost about three or four lengths at the start and trailed throughout.
