### Footnotes

CABO CHICO sprinted clear in the opening strides, was never challenged and extended his advantage while being kept to his task. SEAFIRE was permitted to settle early, dropped inside on the turn and came on without being a factor. MALIBU CANYON was always forwardly placed, came four wide to the stretch but lacked a closing response. DANCING YODELER lagged early, saved ground but never reached contention. DR. J J broke in a tangle and had no speed. SHAGGY NIUNIU stalked three wide to the stretch and came up empty. JOLLY OLLIE flashed speed from the inside and stopped. VENOM G broke poorly and was always outrun.
