DREAM DE JUSTICE broke in stride and took back just off SMOKIN FAME, moved to that rival from the outside on the turn, drew clear in the upper stretch, and drew clear driving. MY ROYAL CAT settled early, raced two wide on the turn and finished willingly. MOMMY GO TOO hopped at the start to be off slow, steadied from the rail at the three eighths, remained inside to the stretch and closed willingly. SMOKIN FAME set the pace from the inside but slackened in the lane. I PROMISE JUSTICE settled early, raced two wide on the turn and went evenly through he lane. BUD I CRUSHED IT lacked good early speed, raced four wide to the stretch and failed to rally. BABY BOY stalked the pace three wide to the stretch and came up empty. BOLD JUSTICE had no speed.
