**Footnotes**

WHISTLE TESTER dueled for the lead from along the outside, came in nearing the three-sixteenths pole, bumped with P.A.'S CANDY repeatedly during the drive and proved narrowly best. P. A.'S CANDY vied for the lead from along the inside, came out nearing the three-sixteenths pole to bump repeatedly with the winner and just missed. MCWEST was in tight along the inside early running up on horses heels, steadied and came out nearing the three-eighths pole taking the path of TOP'S MY POP, then came five-wide into the stretch and finished willingly. CLOSEEYESFANTASIZE saved ground stalking the pace to the stretch, angled out for the drive, but was unable to improve her position late. SOUTHERN KISSES was four-wide throughout, moved up to offer a bid nearing the quarter pole and then flattened out. TOP'S MY POP was forced out and had to steady nearing the three-eighths pole when MCWEST came out, dropped well back and was unable to recover in time. RARE N' TO SYN disputed the pace from between horses for a half mile and gave way. KIND HAPPINESS saved ground to no avail. DON'T TELL LISA showed little. A SPECIAL CHIC was outrun. For interference nearing the three-eighths pole, MCWEST was disqualified from third and placed sixth.
