Footnotes

CYBER MOBILE broke sharply to press the pace from the outside of TWO SOCKS, moved up to take a slight advantage inside the quarter and held that rival off in a stiff drive. TWO SOCKS set a pressured pace from off the rail and gave way grudgingly to the winner in the drive. GOLD BLUFF chased the leaders from the outside throughout and lacked a closing response. U O ME raced off the leaders from the inside, moved up to offer a bid in mid-stretch and failed to sustain his rally in the drive. VICTORS LEGEND was away alertly to chase the leaders from the outside and gradually gave way. BOOTRANDO FIRE raced off the pacesetters from the inside and weakened. CAHILL SLEW lagged early, raced off the rail and did not menace.
