COLONY LANE went to the front soon after the start, opened a clear lead before going a quarter, increased his advantage in mid- stretch and held sway while being shown a turned down whip late. SHOTMO broke sharply to chase the leaders from the outside, could not reach the winner in the drive but finished with good energy. D DEVIL showed no early speed, raced wide into the lane and finished with a late rally. NORTHERN BAQUERO was never far back while racing from between foes and finished evenly. FORESTVILLE was away alertly to chase the leaders from the inside and gave way after a half. NICK N COURT broke awkwardly, saved ground throughout and failed to threaten. PRINCE STATELY showed brief speed and stopped.
