### Footnotes

MO'S FLASHY DATE was away in good order to duel for the early advantage from the outside, opened a clear lead into the lane and increases his margin in the drive. CHARLESISNOPRINCE was bumped at the start, moved up quickly to duel for the lead from the inside, could not stay with the winner in the drive but finished well to hold the place. JIMMY JOE MEEKER hopped at the start, showed no early speed, raced wide through the turn, angled out further approaching the stretch and finished with good energy. RICHARD'SDOINGTIME was bumped at the start, stalked the leader from the outside throughout and lacked the needed closing response. SONAR EXPRESS lacked early speed, raced wide through the turn and was eased through the final yards.
