JOJO'S JUSTICE stalked the pace of NOTHING IN COMMON from the outside, responded to steady urging and wore down that rival in the final yards. NOTHING IN COMMON went to the front at once, opened a clear lead before going a quarter, raced off the rail into the lane and yielded to the winner late. TALENTED TANA was never far back, raced wide through the turn and lacked the needed closing response. MYSTACALLIE raced off the leaders early, moved between rivals nearing the quarter and finished evenly in the drive. POLISH STAR lacked early speed, saved ground through the turn, angled out nearing the quarter and finished evenly. PARADISE CRUISER was bumped at the start, showed no early speed, raced off the rail into the stretch and finished with some late run. PROFITBOX was bumped at the start, lacked early foot, raced wide through the turn and did not threaten. YODELERS DREAM raced off the leaders from between foes and was not a factor. ENDURING PAM lacked early speed, raced wide through the turn and did not offer a bid. KITTY MAC chased the leaders from the inside and weakened after going a half.
