MIMI'S KLEVEN stalked the pace racing three wide, assumed command leaving the second turn, opened clear and maintained a safe advantage. RUNNIGWITHSCISSORS was allowed to settle into stride, angled out entering the stretch to make his bid, and was along in time to earn the place. RED CLOUD settled saving ground, got through and finished willingly to earn the show. CODY WADE pressed the pace racing along the inside, but flattened out during the drive and gave way. SUN SON set the pressured pace racing three wide, but came up empty on the second turn and dropped out. D DEVIL settled in the second flight and failed to respond. TUXTLAN saved ground to no avail. BUCKUPHENRY raced wide throughout and was never a factor.
