JOJO'S JUSTICE raced just off the leaders early, angled out with a furlong to run, responded to steady urging and was up in the final yards. STORMIN LASS dueled for the lead from between foes throughout and finished with good courage to save the place. NO SECONDS PLEASE was away alertly to duel for the lead from the outside and gave way through the final sixteenth. RICH DEBUT was off slow, lacked early speed, saved ground throughout and finished with a steady rally. BOMBAY BEAU dueled for the lead from the inside and gave way through the final furlong. KITTYONTHELOOSE showed no early speed, angled out nearing the quarter and failed to menace. JUST CHUB raced off the leaders from the outside and lacked the needed closing response. DAWN'S WILD ONE lacked early foot, angled out nearing the quarter and was not a factor. KIKI'S DANCE chased the leaders from the outside and weakened after going three furlongs.
