ROCKHILL GOLD broke well, and was taken back while racing wide, and had a late rally. NATALIE ONE was away alertly, set pace inside, and weakened. DANZGAL was away alertly, and pressed pace in between horse, and faded. ANN'S SEVEN broke well, and settled mid pack four wide, and gave way.
