### Footnotes

SCENT OF CHRISM dropped back early,settled far back,and made a strong closing bid in the lane. WHATS UP BETTY was taken back,and made a long sustained bid. TYCHONIC CHOICE pressed the pace from the outside,and faded. ALLUSHA hustled early, to press the pace,and tired.
