### Footnotes

COLOR ME TUFF was off a step slow, rushed up for a contending position along the inside, angled out nearing the five-sixteenths pole, reached the fore into the lane, responded when challenged by ROCKHILL GOLD in mid-stretch and kept that rival at bay in the drive. ROCKHILL GOLD showed no early speed, raced far wide through the turn, moved up to offer a bid nearing the eighth pole but could not match strides with the winner in the drive. LEGENDARY MADAME dueled for the lead from the outside and gave way to the winner after going a half. MY GINNY N TONIC dueled for the lead from the inside and also gave way after a half. BOUNDARY LANE raced off the pacesetters early, moved outside through the turn and failed to rally. MOJAVE CAT lacked early speed, raced wide through the turn and did not menace. DAVESNOTHERE bobbled at the break, showed brief speed and weakened.
