ENROLLMENT stalked on the inside, and moved to the outside, to run down the leader. AVANT GARDE had the early lead, widened the margin, but was caught late. EDDIES SAINT bumped at the start, and settled mid pack, made a mid track bid. DENNY VEE stalked the pace, and finished evenly. CAUTIOUS AFFAIR trailed inside, and made a mild inside rally. MO'EM DOWN was bumped at the start, stalked inside, and had no bid. LAKESHORE COURT was mid pack, and no threat. ZION'S VIEW was bumped at the start, and stumbled, then was hustled to contention, and gave way.
