**Footnotes**

ZINZEE contended racing between horses, got through entering the stretch, wore down R BLOSSOMS AWESOME and steadily edged clear. R BLOSSOMS AWESOME was allowed to settle into stride, came four wide to make a bold bid, poked the head in front with a furlong to run, but was unable to match strides with the winner late. LADY LATIFA pressed the pace racing between horses from three wide, weakened during the drive but had enough left to hold the show. CAITIES MAJESTY set the pressured pace racing three wide, but flattened out entering the stretch and faded. SAN MIGUEL BOY was unhurried early, came three wide to make a belated gain, but failed to seriously threaten. LA BAQUERA raced four wide in the second flight and failed to respond. SNOWBOUND ANGEL pressed the pace racing along the inside, but came up empty leaving the turn and dropped out. TOP BET contended racing along the inside, was caught in tight and steadied sharply near the three-eighths pole, dropped back and never recovered. MEMO BAY showed little. The Stewards conducted an inquiry into the incident near the three-eighths pole, but following the review made no change to the order of finish.
