**Footnotes**

REGGIANO was never far back, angled out nearing the quarter, responded to steady urging and was up in the closing yards. CANTCATCHKATO was bumped at the start, chased the leaders from the outside, moved up to offer a bid nearing the sixteenth pole but could not resist the winner. BROTHER DAVE was away alertly to duel from the outside and gave way grudgingly in the drive. GOLDEN N SWEET broke sharply to duel for the lead from the inside and gave way through the final furlong. PEPPERJACK PETE lacked early speed, saved ground throughout and failed to menace. SONAR EXPRESS was bumped at the start, showed no early speed, raced far wide through the turn and was not a factor. PRINCE BUSTER lacked early foot, raced off the rail throughout and did not reach contention. LAGER MAN was void of early speed, saved ground throughout and did not offer a bid. IRIDESCENT CAT raced off the leaders from the outside and gradually weakened.
