D DEVIL raced off the leaders early, moved outside through the turn, responded to steady handling and proved best late. ROARING TO GO was never far back, raced wide through the turn, moved inside nearing the sixteenth pole and finished with good energy. TAKING LIBERTIES bobbled at the start, raced off the pacesetters early, moved far wide through the turn and finished with a late rally. DECLAN DOWNS was bumped at the start, dueled for the lead from the outside and gave way in the drive. SWISS EXPLOIT was void of early speed, raced wide through the turn and finished with some late run. TOGA CAT lacked early foot, raced far wide through the turn and failed to menace. HIT THE JUICE broke sharply to chase the leaders from the inside and weakened after the opening quarter. GETRDONEGOTRDID was bumped at the start, dueled for the lead from the outside and weakened through the final furlong.
