### Footnotes

THE ROYALS COURT raced off the leaders early, moved out to offer a bid nearing the quarter, opened a clear lead and held sway to the wire. GUSTAVO raced off the pacesetters early, moved outside through the second turn and finished with good energy. CLURMOR lacked early speed, began to advance from off the rail into the stretch, moved inside with a furlong to run and finished willingly. HAPPY ONE went to the front soon after the start, opened a clear lead before going a quarter, saved ground while setting the pace and gave way after three-quarters. MONEY UP FRONT was never far back while racing along the inside, angled out into the stretch and failed to gain in the drive. SWIM AFTER showed no early speed, saved ground throughout and was not a factor. WINGON lacked early foot, raced wide through the turn and did not threaten. AIR MOLECULE showed brief speed and weakened. SLOWWATERRUNSDEEP broke sharply to duel for the lead from the inside and weakened after going a half.
