CHANCY CHANCY stalked the pace racing three wide, ranged up to engage LITTLE PURSUIT entering the stretch, and was fully extended to prevail following a prolonged drive. STATELY'S CHOICE settled racing in hand, slipped through to launch a bold bid entering the stretch, came out under left handed urging and bumped LITTLE PURSUIT nearing the sixteenth pole, was quickly straightened and just missed in a game effort. LITTLE PURSUIT sped clear to dictate terms, was collared between horses entering the stretch, was bumped and steadied when STATELY'S CHOICE came out during the drive and gave way. OUR R. N. chased the pace racing three wide for six furlongs and weakened. ICICLE ANGEL was allowed to settle into stride, but lacked a response when called upon. BLUE ATLANTIS broke awkwardly and showed little thereafter. DAZZLE CAT was fractious in the gate, chased the pace racing along the inside for a half and stopped. The rider of LITTLE PURSUIT lodged an objection against STATELY'S CHOICE, but after viewing the films, the stewards made no change in the order of finish.
