MY MAN DAN stalked the pace, edged closer around the far turn, responded and wore down his chief rival in the stretch run. RING IT UP seized command at once, was challenged into the stretch and outfinished in the final furlong. MACHO BULL reserved from the outset, was angled three wide into the stretch and stayed on. STALKING LION forwardly placed while three wide, was urged to improve on the far turn and came up empty. DUE TO TIMER MALFUNCTION, THE RACE WAS HAND TIMED BY THE EQUIBASE CHART CALLER.
