MY STAR RUNNER raced forwardly while three wide, cruised up on the turn and drew off in the stretch. GALIENTOS dueled, was headed on the turn, proved no match but stayed on. COWBOY'S PRAYER reserved early, moved four wide into the stretch and lodged a mild bid. SCHOOL'S OUT outpaced, entered the stretch five wide and lacked a rally. FREEDOM FIRST was outrun early and never involved. MCLARD flashed brief speed and retreated. SONG OF HUMOR forced the pace, lost his position on the turn and weakened. REACH ONE MORE took no part.
