PROCEED BEE forwardly placed along the inside, was maneuvered off the rail up the backstretch run, took over on the far turn and drew clear in the stretch under confident handling. RED LEAD reserved early, commenced his bid on the far turn, swung out four wide into the stretch and kept on. TOMMY AND BUSTER assumed command early, was urged on the far turn when headed and gave way. B'WANAGOLDMINE settled well, lodged a three wide bid around the far turn but flattened out.
