LAKE KIOWA raced in striking position, took over at the quarter mile marker and edged clear late under steady handling. MOMENT OF SONG was reserved early, closed ground while five wide in the stretch but proved no threat to the winner. SHREWD DEPUTY was void of early speed yet managed to pass tired foes while three wide through the stretch. DIVINE INSPIRATION bounded clear early but faltered on the turn. CONRAD W chased the pacesetter, faded and finished a spent force.
