Footnotes

LIMIT THE WAGON settled while five wide, advanced on the turn, moved five wide into the stretch and rallied under moderate pressure. KAWANGO forwardly placed while five wide, gained a narrow lead on the turn, proved no match but kept on. BLUE OYSTER raced in striking position while four wide, moved five wide into the stretch and stayed on. LAKE LUCERNE set a contested pace, was urged on the turn, headed soon after and yielded. DEVIOUS DENNIS was awkward at the start, rank in the initial stages and failed to recover. ROSS AND ROLL was brushed back at the start and never a factor. THIS ONE CAN RUN drifted in at the start, stalked the early pace and lost his position on the turn.
