CODYS CUPCAKE chased, was urged on the turn and lacked a rally. AM I DREAMIN sluggish at the start, was outrun, swung four wide into the stretch and managed a late bid. SISTER BROWN saved ground and failed to menace. CLOSE CALL fractious in the starting gate, broke her saddle, had her saddle replaced in the paddock and was always outrun. MISIDENTIFIED was outpaced while three wide and never involved.
