DOC'S FRIEND forwardly placed while three wide, entered the stretch three wide, responded to pressure, held sway thereafter and prevailed under a drive. FIRST TO KNOW vied between rivals, gained a narrow lead up the backstretch run and fought back gamely under left-handed encouragement. TRICKY CAUSEWAY dueled, remained along the inside into the stretch and was outfinished. TENTH POWER raced in striking position while four wide and dropped back on the far turn. HERECOMESBERT chased the pace while five wide, was outpaced on the far turn and weakened in the stretch.
