**Footnotes**

WILD L set a contested pace, edged clear at the top of the stretch and held sway under heavy pressure. ROAROFVICTORY chased the pace while six wide up the backstretch run, remained six wide into the stretch and stayed on gamely to garner the place position. DAZZLING MAN saved ground throughout, rallied into the stretch but lacked the needed kick. WILL E SCAT settled well just behind the leaders, advanced on the turn to reach contention but was outfinished. PASS THE AMO was outrun early, lodged a seven wide bid in the stretch and passed tiring rivals. GENERAL DARBY stalked the pace while five wide on the backstretch and gave way in the final furlong. GRAYSIDEOFJUSTICE pressed the pace, remained in contention until the furlong grounds but faded in the late stages.
