HARLEY D reserved early, swung five wide into the stretch, closed with a rush when roused and won going away. JUMP ON BOARD brushed early, raced in striking position while four wide, swept to the front at the head of the stretch but was reeled in late. SMART REALITY stalked the pace, proved no match but kept on well. VELVET RAGE outpaced early, entered the stretch three wide and managed a late bid. DESERT RATTLER prompted the pace and retreated. HALF MOUNTAIN CAT set a contested pace and dropped back on the turn. KING OF THE HILLS broke inwardly and proved no menace. SOUL PROVIDER took no part.
