Non-winners of \$35,000 in 2013 allowed 3 lbs.; non-winners of \$24,000 in 2013 allowed 5 lbs.; non-winners of \$18,000 in 2013 allowed 8 lbs. No nomination fee. \$350 to pass the entry box and \$500 additional to start. \$60,000-guaranteed of which 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$1,200 TO ENTER AND START. Starters to be named through the entry-box by the usual time of closing. Should this race not be divided and the entry number exceed fourteen (14), high weights will be preferred. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into race cancels all fees.

### Footnotes

MAUDE S saved ground, commenced her bid on the far turn, forged clear along the inside into the stretch and held well thereafter under a brisk drive. LAVA GIRL sprinted clear, set tepid fractions, proved no match but kept on well. MISS HOCKADAY settled, moved up while four wide on the far turn, continued four wide into the stretch and stayed on to secure a minor share. ITSABEAUTIFULTHING reserved, advanced while three wide around the far turn, moved three wide into the stretch and was outfinished. BACK TO HURSTLAND moved up leaving the first turn to stalk the pace and dropped back on the far turn.
