JACO RED stalked, dueled around the far turn, responded to pressure and wore down CRAZYCOOP. The latter dueled, held well into the stretch, managed a game effort but came up short. HIGHEST ORDER was reserved along the inside and stayed on in the stretch. DE BACK IN TOWN settled, entered the stretch three wide, offered a bid but lacked the needed kick. STICK SHIFT passed tired ones. TOMMY TWO STROKE never menaced. PAMPERO STORM flashed brief speed. SEATTLE GIANT was always outrun. RURAL NEOPOLITAN was never involved. BOOK OF LIFE retreated.
