LETS JUST SAY settled while four wide, moved four wide into the stretch and held sway under a drive. GLORY BE WILD pressed the pace, gained the lead on the turn, drifted in twice during the stretch run under right-handed pressure and kept on. ELEVEN GAGE reserved while three wide, swung six wide into the stretch and lodged a belated bid. FROZEN ANGEL stumbled at the start, set a contested pace, was headed on the turn and lacked room in the stretch. C J RAMROD never menaced. O DEVIL forwardly placed while six wide, entered the stretch five wide and faded. ALESIAS GOLD outrun early, moved out seven wide into the stretch and was never a factor. FEZ UP flashed brief speed. FOLLOWING THE RACE, THE STEWARDS CONDUCTED AN INQUIRY INTO INCIDENTS DURING THE STRETCH RUN. AFTER REVIEWING VIDEOTAPED REPLAYS, THEY DISQUALIFIED GLORY BE WILD FOR INTERFERENCE AND PLACED HIM FOURTH.
