MORRISON outpaced while five wide, entered the stretch three wide and lodged a mild bid. DEVIOUS DENNIS set a contested pace, was headed on the turn and yielded. MR. KRUIDENIER raced forwardly while four wide and faded. FROST forced the pace and faltered. HORSE GO trailed.
