APPEALING OKIE sprinted clear early, turned away a brief bid from R SUZIE Q approaching the stretch, kicked clear in upper stretch and widened to the wire under steady handling. JULIES OPPORTUNITY raced three wide in midpack on the turn, finished willingly to gain the place in the final strides. R SUZIE Q chased the winner to the stretch, couldn't keep pace in upper stretch, weakened and lost second late. CALLING UNITY broke alertly, chased the top pair to the stretch before tiring. STARLET SKY saved ground racing well back to the stretch and was never a factor. MIKI TRIKI showed little. CONVICHE and BLOOMINATION were both outrun.
