FOR THREE-YEAR-OLDS. Weights: 122 lbs. Non-winners of \$50,000 at a mile or over in 2008 allowed 3 lbs., non-winners of \$40,000 in 2008 allowed 6 lbs., non-winners of \$20,000 in 2008 allowed 9 lbs. No nomination fee. \$1,000.00 to pass the entry box on Monday, June 23. \$2,500 additional to start on Friday, June 27 with \$250,000 guaranteed of which \$150,000 to the owner of the winner, \$50,000 to second, \$25,000 to third, \$12,500 to fourth, \$7,500 to fifth, \$5,000 to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$5,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds the starting gate capacity, high weights will be preferred. Different owners will have equal draw according to the weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees.

TIZ NOW TIZ THEN settled well off the rail in the four path, commenced his bid entering the far turn, moved five wide into the stretch, rallied strongly and was going away at the finish. MAYA'S STORM raced forwardly while four wide, continued four wide into the stretch, lugged in while under pressure just inside of the furlong marker hampering ACTING ZIPPY and kept on willingly thereafter. REPENTING sprinted clear, held well into the stretch, stayed on but was outfinished by the top pair. DAY OF VICTORY void of early speed, swung six wide into the stretch and lodged a belated bid. ACTING ZIPPY stalked the pace, remained in contention in mid stretch, was checked inside the furlong marker and failed to recover. SEBASTIAN COUNTY saved ground, was placed in tight quarters at the three-sixteenths marker and lost his momentum. Z FORTUNE reserved in traffic, pulled against his rider's restraint, lacked room in the stretch run and faded in the final furlong. RICH YOUNG RULER was off a step slow, never involved and eased down late. FOLLOWING THE RACE, THE RIDER OF ACTING ZIPPY CLAIMED FOUL AGAINST THE RIDER OF MAYA'S STORM ALLEGING INTERFERENCE JUST INSIDE THE FURLONG MARKER. AFTER A REVIEW OF THE VIDEO REPLAY, THE STEWARDS DISQUALIFIED MAYA'S STORM FROM SECOND AND PLACED HIM FIFTH.
