SOUTH TULSA COUNTY vied for the lead between foes, entered the stretch three wide, edged clear and held well. BULLZABOY settled between rivals, moved four wide into the stretch and stayed on. HIGHFLYERTOTHELINE reserved, swung five wide into the stretch and finished well. WINTER CANYON outrun early, moved four wide into the stretch and lodged a belated bid. PACIFIC DANGER outpaced while six wide, remained six wide into the stretch and managed no rally. CROYDON JUNIOR gained the lead, was headed leaving the turn and yielded. MISCHIEF LANE edgy before the start, bobbed at the break and displayed brief speed. KOLLEGE was off slowly and proved no menace. NANTACHIE JOE took no part.
