**Footnotes**

SHORTY SMALL stalked the early going from the inside, crept closer entering the second turn, gained command entering the drive, opened a clear margin at the eighth pole and was clear late while kept to task. DYNAMIC FORCE seven wide into the first turn, was unhurried early, advanced outside, responded entering the drive but could not reach the winner. BRINKER stalked the early pace from the inside, dropped back up the backstretch, altered outside, responded and was gaining late. HOLIDAY JUSTICE was outrun early, made a bid entering the drive and had a mild late gain. LOCOMOTION was carried seven wide into the first turn, chased the early pace and had nothing left. CAJOLE forced the early pace from the inside but had nothing left for the drive. DR. SEACLIFF away in good order from between foes to set the early pace, tired in the drive. NORTH OF TIME was six wide into the first turn, carried foes out and was never close.
