GINA'S WISH forced the pace, led on the turn and came up empty in the stretch. MOTION IN POTION was outpaced while four wide and posed no threat. LAWYER ANN dueled, was headed on the turn and yielded. K T'S A FLYIN was always outrun. LUCIAS' BENT TREE was never involved.
