YULE YARNS GIRL grabbed the lead, edged clear into the stretch and held sway under brisk pressure. YANKEEDOODLE CANDY stalked the pace, responded to pressure and stayed on. CLOSE CALL leaned in at the start, moved closer on the turn, entered the stretch three wide and made a bid. DAZZLING GLITTER slammed at the start, moved four wide into the stretch and lodged a mild bid. MEGUMI chased along the inside and weakened. TASHIMA never menaced. BASIN HARBOR was always outrun. DEVILS LOOT dwelt at the start and proved no factor.
