PAY THE TICKET stalked the pace while five wide, edged closer on the turn, responded to a drive and held sway in the stretch. BACK TO BACK outrun early, swung five wide into the stretch and exhibited late energy. BRASSY'S DELIGHT veered in at the start, set a pressured pace and was worn down late. DEVILS BULLION raced forwardly between foes, angled in for the stretch run and had no finishing punch. BLAZED GLORY broke inwardly, brushed the rail early, prompted the pace and finished greenly when drifting out in the stretch. RAINBOW EDDIE brushed at the start, was outpaced, entered the stretch three wide and managed no rally. ANNIES BLUFF was void of speed.
