ROCHELLE ROCHELLE moved up between foes, took the lead entering stretch and lasted. MIZ MAGGIE MAE raced outside, moved closer to rail after taking the lead, fell back slightly but then was coming back. SIVORY bore out entering first turn, eased out stretch and then had no late rally. SIMPLY WICKED raced outside and passed tiring foes. MADISON PRINCESS raced wide and failed to menace. A LITTLE AT A TIME moved off the rail final turn and was no threat. THORNWELL was well placed between foes, tired. CALOCAGATHIA bobbled leaving the gate. JULIE'S CADICE failed to menace. SWALES PARK set the pace well off the rail and stopped. SASSY DIVA saved ground and stopped.
