SPANISH KITTEN was off slowest, rallied wide, took the lead near stretch, opened a clear lead with a furlong to run, drifted out when put to left handed pressure in deep stretch and lasted. ROCK PTARMIGAN was outrun early, rallied extremely wide on the final turn and into stretch, challenged in deep stretch, was carried out and hung. A CLAIM OF FOUL BY THE RIDER OF ROCK PTARMIGAN AGAINST SPANISH KITTEN FOR INTERFERENCE IN THE STRETCH WAS DISMISSED. SPECIAL ENERGY saved ground, swung wide rallying, drifted in deep stretch and was too late. ICE PILOT joined for command four wide near stretch and gave way. ST ANDREWS passed tiring foes. TERMINAL VELOCITY saved ground disputing the pace and tired. L'EMPEREUR joined for command three wide and then tired. EIGHT KARET LIE failed to menace. APIANUS vied for command two wide and tired. HE'S ROUGH N READY was well placed between foes, drifted out badly under left handed pressure through the stretch.
