MR WEAVER broke sharp to set the pace to deep stretch then was not good enough for the winner. FIVEFOURTHREEWONE was under a long drive to gradually close the gap in the final furlong. WINNING DEAL was outrun early then finished well near the inside. ADAMS RUN chased the leader into the final furlong then weakened. DECORATED ADMIRAL showed little. RED DOCTOBER lacked a rally. JUDICIOUS CAT showed early speed then tired. ESTRELLA CORREDOR lacked a rally. TRUANCY was through early.
