I'M BROKE saved ground, took the lead in deep stretch and slowly edged clear. MAYFEVER raced wide and closed for place. ROCK PTARMIGAN raced between foes, took the lead on the final turn but then weakened. LAWYER TOM split rivals on the final turn and was too late. STEINBRENNER set the pace out from the rail and tired. CLIFF was fractious in the gate, raced wide. BRUSHED failed to menace. INTERROGATE ME was wide and just off the pace, stopped. WATCH YOUR TEMPER was just off the rail, stopped.
