DOCTOR DINERO moved up outside rivals leaving the turn, gained the lead in upper stretch then drove clear. WATERFALL vied for the lead from the outset and held on well in the drive for second. MARQUET DANCER, never far back, finished well to get up in time for third. TINDER LORD moved up wide leaving the turn then closed well. DISTINCTIVE ALIBI pressed the pace outside rivals and faded in the drive. KAT'S HOPE was shuffled back at the start. FOREST HILLS DR tired. ILLEGAL INTRUDER vied for the early lead along the inside then tired. CLASSY ORIENTATION showed little. DIAMOND COUNTY tired. A claim of foul by the rider of KAT'S HOPE against WATERFALL for interference at the start was not allowed.
