LIGHT SENTENCE was outside second flight, eased out wider, closed and won going away. MICHAEL'S TRIFECTA raced inside winner, challenged for the lead leaving furlong grounds but was no match late. BIG DEALER set the pace outside, faded. GOLDEN WEEKEND raced wide. BLAME THE JOCKEY steered wide and was no factor. SHOWMANSHIP saved ground, steadied on the far turn. A CLAIM OF FOUL BY THE TRAINER OF SHOWMANSHIP AGAINST MICHAEL'S TRIFECTA FOR ALLEGED INTERFERENCE NEAR THE 3/8 POLE WAS QUICKLY DISMISSED.
